Acceptance

 The Customer is taken to have exclusively accepted and is immediately bound, jointly and severally, by these terms and conditions if the Customer places an order for or accepts delivery of the Goods.
 These terms and conditions may only be amended with the Seller's consent in writing and shall prevail to the extent of any inconsistency with any other document or agreement between the Customer and the Seller.

- Price and Payment
 At the Seller's sole discretion, the Price shall be either:

 (a) as indicated on any invoice provided by the Seller to the Customer; or (b) the Seller's quoted price (subject to clause 4.2) which will be valid for the period stated in the quotation or otherwise for a period of thirty (30)

 The Seller reserves the right to change the Price if a variation to the Seller's quotation is requested. Any variation from the plan of scheduled works or specifications will be charged for on the basis of the Seller's quotation and will be shown as variations on the invoice. Payment for all variations must be made in full at their time of completion.

 At the Seller's sole discretion, a deposit may be required. The deposit amount or
- amount or percentage of the Price will be stipulated at the time of the order of the Goods and shall become immediately due and payable. Time for payment for the Goods being of the essence, the Price will be payable by the Customer on the date/s determined by the Seller, which

 - (c) thirty (30) days following the end of the month in which a statement is

 (d) that the Customer's exertine accounts loan programmer parker and the care.

 - committed a serious credit infringement (that is, fraudulently or shown an intention not to comply with the Customer's credit obligations);
